The purpose of this communication is to inform you and prepare you for the upcoming community wide termite inspection being conducted by Payne Pest Management to check for termite activity. This inspection will be held on Thursday, July 9, 2020 and Friday, July 10, 2020 depending on your address. Enclosed is a schedule of the dates and times we will be conducting our inspection for each building. Please note that in order to efficiently complete the inspections, we are unable to accommodate individual appointments.

To complete these inspections, it will be necessary for our inspectors to gain access to the interior and exterior of your home to perform an inspection of the interior, attic, and balcony areas of each unit. Please ensure that any fragile items are removed and that your pets are secured in a suitable area to ensure their safety.

Someone over the age of 18 is required to be home during the procedure. If you are not able to be home during the scheduled date and time, please make arrangements to have your neighbor, or a friend, provide access into your unit to complete the inspection.

If your unit is rented, it is the unit owner's responsibility to notify their tenants of this upcoming inspection.

Thank you for your cooperation for this inconvenient, but necessary work. We are striving to ensure that every resident enjoys a safe environment, and these inspections are part of our commitment.
